

**ORDINANCE NO. 2010-02**

AN ORDINANCE BY THE CITY OF CROUCH, IDAHO, TO SET A NEW TIME FOR THE REGULARLY SCHEDULED MONTHLY COUNCIL MEETINGS AND PROVIDING FOR AN EFFECTIVE DATE.

Whereas, the regularly scheduled City Council meetings were scheduled to be held on the first Wednesday of each month at 7:00p.m.; and,

Whereas, the time of these meetings conflict with the schedule of the current Council members; and

Whereas, Idaho State Statute 50-705 requires that the time and place of the regular meetings of the city council shall be established by ordinance;

BE IT ORDAINED by the Mayor and Council of the City of Crouch, Boise County, Idaho, that the regularly scheduled Council Meetings of the City of Crouch shall be held on the second Wednesday of the month, commencing at 6:30 p.m. at the Community Hall located at 1022 Old Crouch Road in Crouch, Idaho.


EFFECTIVE DATE: This ordinance shall take effect and be in force from and after its passage, approval and publication. In lieu of publication of the entire ordinance, a summary of this ordinance may be published in compliance with Section 50-901A, Idaho Code.

PASSED under suspension of rules upon which a role call vote was taken and duly enacted an Ordinance of the City of Crouch, Boise County, Idaho, at a convened meeting of the City Council held on the 10th day of March 2010.

Crouch, Boise County, Idaho, adopted on March 10, 2010, is as follows:


Section 1: Establishes that the regularly scheduled Council meetings shall be held on the

ordinance.
