

**SUMMARY OF
ORDINANCE NO. 2015-03**

AN ORDINANCE ADOPTING THE FISCAL YEAR 2016 BUDGET AND
PROVIDING AN EFFECTIVE DATE

A summary of the principal provisions of Ordinance No. 2015-02 of the City of Crouch, Boise County, Idaho, adopted on August 12th, 2015, is as follows:

Section 1: Amends the budget as set forth in the table below.

ORDINANCE NO. 2015-02

AN ORDINANCE TITLED THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2015, APPROPRIATING THE SUM OF ONE HUNDRED SIXTY ONE THOUSAND, FIVE HUNDRED AND TWENTY SIX DOLLARS AND 82 CENTS, TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF CROUCH FOR THE FISCAL YEAR AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH THE APPROPRIATION IS MADE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Crouch, is a municipal city organized and existing pursuant to Title 50 of the Idaho Code; and

WHEREAS, pursuant to Idaho Code Section 50-1001 the City of Crouch fiscal year begins on the first day of October; and

WHEREAS, pursuant to Idaho Code Section 50-1003, the City Council shall adopt an annual appropriation ordinance prior to the commencement of each fiscal year, which in no event shall be greater than the amount of the tentative budget; and

WHEREAS, the City of Crouch considered the proposed budget and conducted a public hearing thereon, on August 12, 2015 and determined that the budget as amended should be adopted.

NOW, THEREFOR, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF CROUCH, IDAHO, as follows:

Section 1: That the sum of ONE HUNDRED SIXTY ONE THOUSAND, FIVE HUNDRED AND TWENTY SIX DOLLARS AND 82 CENTS (\$161,526.82) be appropriated to defray the necessary expenses and liabilities of the City of Crouch, Boise County, Idaho for the fiscal year beginning October 1, 2015.

Section 2: The objects and purposes for which such appropriation is made, and the amount of each object and purpose is as follows:

General Fund – \$70,008
Street Fund - \$9,823.82
Hall Fund - \$6,195
Museum Fund - \$8,500
Garden Valley Center for the Arts - \$53,500
Total - \$161,526.82

Section 3: All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

Section 4: This ordinance shall take effect and be in force from and after its passage, approval and publication. In lieu of publication of the entire ordinance, a summary of this ordinance may be published in compliance with Section 50-901A, Idaho Code.
