

ORDINANCE NO. 2026-02

AN ORDINANCE TITLED THE ANNUAL APPROPRIATION FOR THE FISCAL YEAR BEGINNING OCTOBER 1,2026,

APPROPRATING THE SUM OF SEVEN HUNDRED AND EIGHT THOUSAND, SEVEN HUNDRED AND TWENTY-ONE DOLLARS TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF CROUCH FOR THE FISCAL YEAR AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH APPROPRIATION IS MADE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Crouch, is a municipal city organized and existing pursuant to Title 50 of the Idaho Code; and

WHEREAS, pursuant to Idaho Code Section 50-1001 the City of Crouch fiscal year begins on the first day of October; and

WHEREAS, pursuant to Idaho Code 50-1003, the City Council shall adopt an annual appropriation ordinance prior to the commencement of each fiscal year, which in no event shall be greater than the amount of the tentative budget; and

WHEREAS, the City of Crouch considered the proposed budget and conducted a public hearing thereon, on August 12th, 2026 and determined that the budget should be adopted.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the City of Crouch, Boise County, Idaho, as follows:

Section 1: That the sum of Seven Hundred and Eight Thousand, Seven hundred and Twenty-One dollars (\$708,721) be appropriated to defray the necessary expenses and liabilities of the City of Crouch, Boise County, Idaho for the fiscal year beginning October 1,2026.

Section 2: The objects and purposes for which such appropriation is made, and the amount of each object and purpose is as follows:
