

ORDINANCE 2026-03

AN ORDINANCE AMENDING ORDINANCE NO. 2025-01, THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2025, APPROPRIATING ADDITIONAL MONIES

WHEREAS, the City of Crouch, is a municipal city organized and existing pursuant to Title 50 of the Idaho Code; and

WHEREAS, pursuant to Idaho Code Section 50-1001 the City of Crouch fiscal year begins on the first day of October; and

WHEREAS, pursuant to Idaho Code 50-1003, the City Council shall adopt an annual appropriation ordinance prior to the commencement of each fiscal year, which in no event shall be greater than the amount of the tentative budget; and

WHEREAS, the City of Crouch considered the proposed budget and conducted a public hearing thereon, on August 12th, 2026 and determined that the budget should be adopted.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the City of Crouch, Boise County, Idaho, as follows:

Section 1: That Ordinance No: 2025-01, the appropriations ordinance for the City of Crouch, Idaho, for the fiscal year commencing October 1, 2025 is hereby amended as follows:

That the additional amount of \$14,500.00 be appropriated out of the revenues of the Local Option Tax Fund to be used for authorized activities.

Section 2: The objects and purposes for which such appropriation is made, and the amount of each object and purpose is as follows:
